INSTALLATION OF 30M SHARED COMMUNICATIONS MAST, 6 ANTENNAS, 2 TRANSMISSION DISHES, GROUND-BASED EQUIPMENT CABINETS & ANCILLARY ALL WITHIN TIMBER-FENCED COMPOUND AT FIELD AT OS 270895 123153 LAND EAST OF CHEYNEY LANE GEORGE NYMPTON SOUTH MOLTON
It was disclosed by the landowner that the plans are incorrect, the access gate is in the wrong place, and it is assumed an amendment will have to be made. Also, the description is incorrect, the location is West of Cheyney Lane not East, we understand Arqiva have informed the planning department of this error. Clerk to ask the planning department if this means that the application will have to be re-advertised. Therefore, the Council felt it needed more information before a decision could be made.
The Company responsible for the installation, Arqiva, have offered to do a Flag Wave Trial for the Council and residents to see exactly how this 30M mast will impact on the surroundings. The Council have agreed and have requested that they go ahead.
