- 2016/116 Apologies/Attendance Register** – Apologies received from Adele Poole on holiday and Sarah Leworthy has resigned due to family commitments.
- 2016/117 Disclosable pecuniary interests** – There were none.
- 2016/118 Announcements from the Chair** – Greener for Life have withdrawn the planning application for the digestate lagoon. They now plan to pipe the digestate across the fields with take-off points as far as Parsonage Farm. They also informed us that there would be retrospective applications re the anaerobic digester at Great Hele Farm.
- 2016/119 Questions from the Public** – Public Footpath sign has gone missing just outside the village, the Clerk will inform the Council.
Jane Smith was concerned re the building work at Hillside, she was reminded that anyone can report their concerns to the Planning Authority.
Greener for Life have said they will do a presentation to the village re the digestate so any questions raised can be answered then. They have also invited the Councillors to see the Anaerobic Digester at Great Hele Farm.
